CONDITIONS

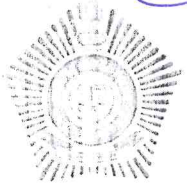
- 1) This licence is granted subject to compliance of the provisions of PSARA 2005 and Rules 4 of Maharashtra PSARA Rules 2007.
- 2) The licensee shall employ Security Guards as per provision of section 10 of PSARA 2005 and Rules 4 & 6 of Maharashtra PSARA Rules 2007. The Compliance about the same should be done within a period of 6 months from the date of obtaining this license, failing which the same shall be revoked.
- 3) The licensee shall ensure that Security Guards/Supervisor of the private security agency shall undergo such training as is prescribed in Section 9 in the PSARA 2005 and Rules 5 & 7 of Maharashtra PSARA Rules 2007, within a period of 6 month from obtaining this license, failing which the same shall be revoked.
- 4) The licensee shall ensure that every security Guard/Supervisor working for it undergoes a medical examination as prescribed in Rule 6 of Maharashtra PSARA Rules 2007.
- 5) The licensee shall intimate the name, parentage, date of birth, permanent address for correspondence and the principal profession of each person forming the Agency within fifteen days of receipt of the license to the Controlling Authority as per sub Rule (2) of Rule 10 of Maharashtra PSARA Rules 2007.
- 6) The licensee shall inform the Controlling Authority regarding any change in the address of persons forming the Agency, change of management within seven days of such change as laid down in section 11 of PSARA Rules 2005.
- 7) The licensee shall immediately intimate to the Controlling Authority about any criminal charge made against the persons forming the Agency or against the private security guard or supervisor engaged or employed by the Agency, in the course of their performance of duties as agency. A copy of such Communication shall also be sent to the officer in charge of the police station where the police station where the person charged against resides as per sub Rule 4 of Rule 10 of Maharashtra PSARA Rules 2007.
- 8) Every licensee shall abide by the requirements of physical standards for the private security guards and their training as is prescribed in the Private Security Agency (Regulation) Act 2005 and Maharashtra Private Security Agencies Rules-2007 as the condition on which the license is granted.
- 9) License fees is non-refunded as per sub Rule 6 of Rule 10 of Maharashtra PSARA Rules 2007.
- 10) Licensee shall maintain a register containing Management details, Security Guard & Supervisor, Customers & Duty Roster as mentioned in section 15 of PSARA 2005.
- 11) As provided in the sub Rule 1 of Rule 16 of Maharashtra PSARA Rules 2007 every agency shall issue a uniform and make it obligatory for its security guards and supervisors to wear while on duty and also make obligatory to put on :-
 - a) An arm badge distinguishing the Agency.
 - b) Shoulder or chest badge to indicate his position in the organization
 - c) Whistle attached to the whistle cord and to be kept in the left pocket
 - d) Shoes with eyelet and laces.
 - e) A headgear which may also carry the distinguishing mark of the Agency and scrupulously follow section 21 of PSARA 2005.
- 12) The uniform used by the private security guards shall not resemble the uniforms of the Armed Forces or the Paramilitary Forces or the Police, as per sub Rule 2 of Rule 16 of Maharashtra PSARA Rules 2007.
- 13) The clothes worn by the private security guard while on active duty shall be such that they do not hamper in his efficient performance. In particular, they shall neither be too tight nor too loose as to obstruct movement or bending of limbs, as per sub Rule 3 of Rule 16 of Maharashtra PSARA Rules 2007.
- 14) Every private security guard shall carry a notebook and a writing instrument with him, as mentioned in sub rule 3 of Rule 16 of Maharashtra PSARA Rules 2007.
- 15) Every private security guard while on active security will wear and display photo identity card issued under section 17 of the Act, on the outer-most garment above waist level on his person in a conspicuous manner.
- 16) Licensee shall exhibit its license or copy thereof in a conspicuous place of its business as mentioned in section 12 of PSARA 2005.
- 17) As provided in the sub section 1 of section 8 of PSARA 2005, an application for renewal of licence shall be made to the Controlling Authority, not less forty-five days before the date of expiry of the date of the period of validity thereof.

- २) एम्प्लॉईज स्टेट इन्शुरन्स ॲक्ट-१९४८ खाली नोंदणी केल्याची प्रत.
- ३) फायनान्स ॲक्ट-१९९४ च्या चॅप्टर-अ अंतर्गत सेंट्रल एक्साईज कडील प्रमाणपत्राची प्रत.
- ४) रिजिनल प्रॉव्हिडेंट फंड कमीशनर यांच्या कार्यालयात नोंदणी केल्याची प्रत.
